## Provision of information to the data subject

Pursuant to Section 19 of Act No. 18/2018 Coll. on the Protection of Personal Data and on Amendments and Additions to Certain Acts (hereinafter also referred to as the "Act") and Article 13 of Regulation (EU) No. 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter also referred to as the "EU Regulation"), the controller shall provide the data subject with the following information when obtaining his or her personal data:

- 3. The purpose of the processing subject's personal data is to provide expert evaluations of the project proposals of Recovery and Resilience Plan of the Slovak Republic
- 4. The legal basis for the processing of personal data is the performance of tasks carried out in the public interest or in the exercise of official authority pursuant to Article 6(1)(e) of the EU Regulation.
  - The controller has tasks as an intermediary pursuant to Section 6(4) and (10) and Section 11 of Act No. 368/2021 Coll. on the Recovery and Resilience Support Mechanism and on Amendments and Additions to Certain Acts.
- 5. The controller shall process only those personal data which are strictly necessary for the achievement of the stated purpose and which are provided for by the special regulations referred to in point 4, as a rule, name, surname and title, address, date of birth, number of identification document (ID card or passport), nationality, date of birth), payment data (e.g. bank account).
- 6. Cross-border transfer of personal data to third countries outside the European Economic Area (EU, Iceland, Norway and Liechtenstein) is not intended by the controller.
- 7. The controller only discloses personal data of natural persons to the extent necessary and always under confidentiality of the data recipient, in particular:
  - to employees of the controller and to invited persons,
  - authorities and other bodies under specific regulations<sup>1</sup> involved in the management, audit and control of the recovery and resilience support mechanism, including financial management, and their employees and invitees, in particular the Government of the Slovak Republic, the implementing body, the audit authority, the body ensuring the protection of the financial interests of the EU,
  - the European Commission, the European Court of Auditors and their staff and invitees,
  - authorities under special regulations<sup>2</sup> and their employees and invitees,

- 8. In accordance with Articles 15 to 22 of the General Data Protection Regulation (EU Regulation), the data subject is entitled to exercise the following data subject rights by means of a request:
  - the right to obtain confirmation of the processing of personal data,
  - the right to obtain access to the personal data, including relevant information relating to their processing,
  - the right to rectification of inaccurate or incomplete personal data concerning him or her,
  - the right to erasure of personal data concerning him or her,
  - the right to restrict the processing of personal data,
  - the right to the portability of personal data,
  - the right to object to the processing of personal data.
- 9. The data subject shall be entitled to lodge a request for the exercise of the data subject's rights with the controller or with the controller's responsible person.
- 10. If the data subject considers that his or her rights have been violated in the processing of personal data, he or she shall have the right to file a petition for initiation of personal data protection proceedings with the Office for Personal Data Protection of the Slovak Republic in accordance with the provisions of Act No. 18/2018 Coll. on the Protection of Personal Data and on Amendments and Additions to Certain Acts, as amended.
