The European Commissioner for Justice, Mr. Didier Reynders, and the State Secretary of the Ministry of Economy of the Slovak Republic, Mr. Vladimír Šimoňák, cordially invite you to the Consumer Dialogue in Slovakia, which will take place on 8 March 2024 at 10:00 at the premises of the Representation of the European Commission in Slovakia, Palisády 29, 811 06 Bratislava.

In its consumer policy strategy for 2020-2025, the New Consumer Agenda, the European Commission underlined its intention to put in place consumer policy instruments to protect all consumers when dealing with professional traders. It attaches special importance to groups of consumers who are particularly vulnerable in certain situations and need increased protection.

Over the past period, several pieces of legislation have been adopted at European Union level to promote a high level of consumer protection and legal certainty for all parties involved. The new challenges of the times, such as rising prices and interest rates due to inflation, consumers' lack of awareness of their consumer rights and advancing digitalisation increase the risk of infringements of the rights of vulnerable consumers. Lack of skills, capabilities or potential inability to integrate into the digital transformation process must not discriminate against those whose consumer rights should be promoted and protected as a priority.

In order to discuss topical consumer protection issues, the European Commission organises a series of events in the Member States called Consumer Dialogues, to discuss with national authorities and stakeholders their experience with the Consumer Agenda, to take stock of consumer policy and to promote cooperation on consumer protection.

The Consumer Dialogue in Slovakia is organised by the European Commission in cooperation with the Ministry of Economy of the Slovak Republic. After an introductory video message by European Commissioner for Justice Didier Reynders and a contribution by Vladimír Šimoňák, State Secretary of the Ministry of Economy of the Slovak Republic, a panel discussion will take place with a representative of the European Commission, public authorities in the Slovak Republic and other stakeholders.
