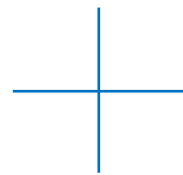

RIA 2020 - a transition to a new culture of better regulation in the Slovak Republic

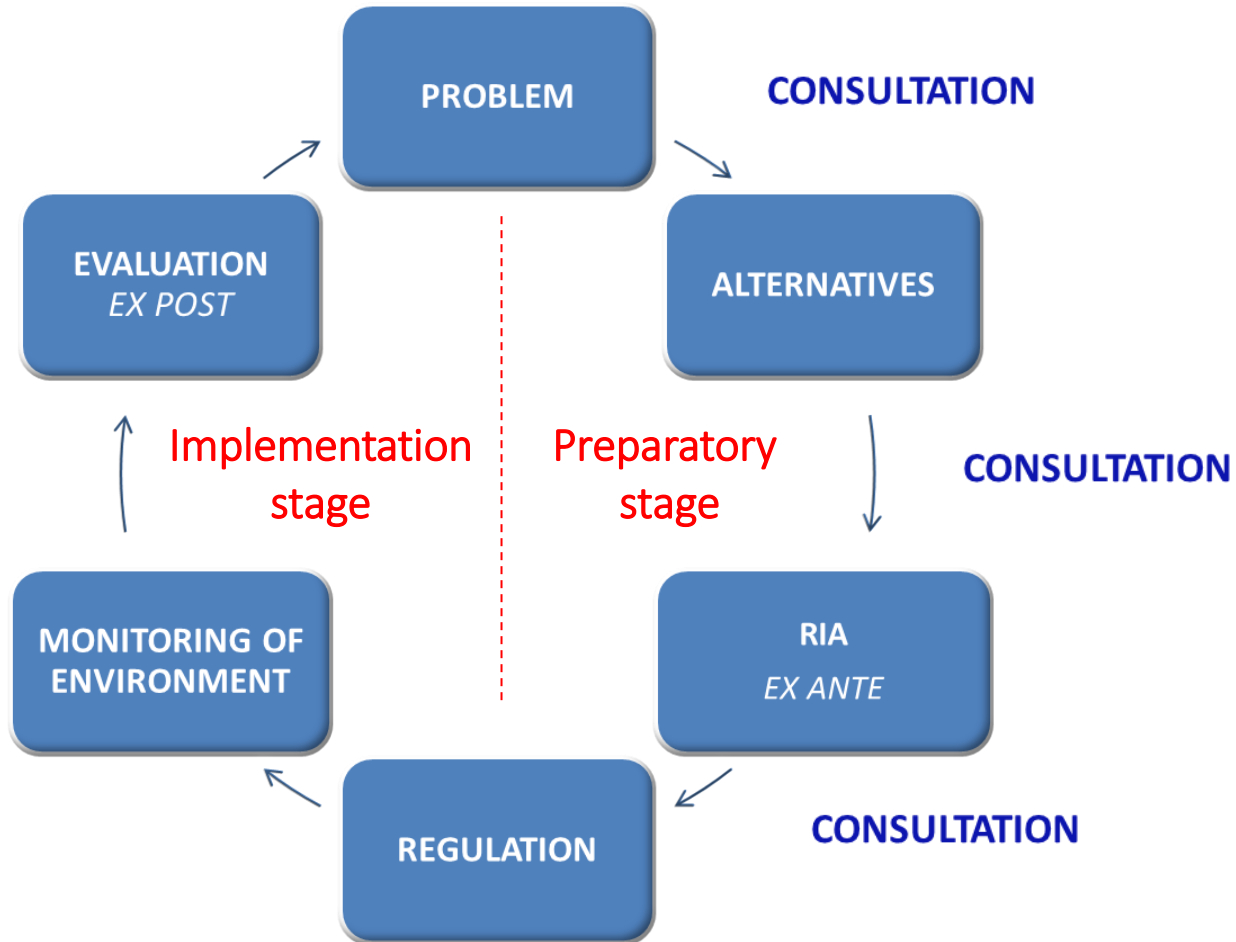
- RIA 2020 - will raise public awareness of better regulation and its benefits.
- Regulatory Impact Assessment - a part of the new regulations' preparatory stage.
- Existing regulations - evaluated on a systematic basis according to the changes in environment.
- Those which will be assessed as inefficient or redundant will be modified or abolished from the regulatory framework.
- Complex IT Platform for Better Regulation will be a key component in fulfilment of the vision.

BETTER REGULATION IN THE SLOVAK REPUBLIC

The general objective of Regulatory Impact Assessment is **to assess** their **positive** and **negative** effects on **selected areas**:

- the budget of the public administration,
- the business environment,
- the social environment and the standard of living,
- the environment,
- the informatization of the society,
- services provided to citizens by the state administration.
